29. Penal Provisions for Fraud by Ineligible Beneficiaries

(1) If any person coming under the exclusion criteria notified by the State Government obtains a ration card by providing false information, the following action shall be initiated against such person, namely;

- Criminal proceeding will be initiated;
- The market cost of the food grains taken by such person shall be recovered from him/her as an arrear of land revenue with 10% rate of interest per annum from the date of receipt of the subsidized food grain.
- In case of employees of Government or Corporation or PSU, Departmental Proceeding shall be initiated against such employees.
