- 1. Agency shall furnish detailed list of advertisement place whether it be on Government or CMC or Private land given with the details of the advertisement as in the format given in Annexure-'A' prescribed for the purpose.
- 2. The agency after being registered under the shall be given Registration No. and code against each hoarding which shall be used in every place/site of their hoarding/ kiosks/ glowsign. This Registration No shall be printed/engraved in a minimum space of their advertisement on hoardings/ kiosk/ glow sign. It should be mandatory for any of the Advertising Agency after being registered by the CMC to either engrave or print on their advertisement materials the registration No allotted by the CMC so as to become visible to the public notice.
- 3. If the agency found absent of having emboldened/engraved the registration No in their all type of hoardings/ kiosks/ glow sign with a period of 15 days time of the permission date, those hoarding shall be removed/ destroyed on the ground of being unauthorized.
- 4. The name and style of the agency as given to the registering authority here the CMC and the same if accepted by the Registering authority, that shall not be changed or altered in any manner without prior permission of the local authority here the CMC.
- 5. The agency can have no rights to erect any of the hoarding/ kiosks/ glow sign beyond the details given in their list under Annexure. Any errection of hoarding at any place within the area of CMC as not in the list shall render itself to be demolished without any notice.
- 6. No hoardings can be sublet to any of the agency either by way of mutual agreement or informal arrangement or understanding whatsoever.
- 7. The agency shall be liable to pay the trade tax as provided under Trade Act. It (Agency) shall be required to renew the Registration period for successive years at every interval of one year in order to get the registration validated.

- 8. The registration authority here for purpose of registration of Advertising Agency under Trade Act read with the provisions of Urban Advertising Policy, 2013 reserves the right to supplement any other condition as may be felt necessary keeping in view the proper regulations of the advertisement within their own area for public interest.
