## Advertisement

Commissioner, Cuttack Municipal Corporation invites an application of bids for letting Mini Goods/Garbage carrier with special built compartments for garbages mounted on it on the following terms & conditions.


- > That the vehicle should have 2 compartments with equal size fixed on it.
- > One compartment shall be meant for dry materials coloured Blue and other is for wet materials coloured Green.
- > The size of the vehicle should be such that it can enter inside the different narrow roads of Cuttack town.
- > That the operation & maintenance of the vehicle shall be the responsibility of owner.
- > That the owner shall provide driver with vehicle & shall take all responsibility of driver.
- > That the vehicle should have facility to keep the garbage container closed while carrying the same.
- > That the vehicle should be provided with GPRS system.
- > That the vehicle should be fitted with one hand bell for ringing.
- > That the vehicle should have music facility for public awareness.
- > That the tenure of hire period shall be minimum 2 years & renewable afterwards.
- > That the owner shall supply necessary fuel for running of the vehicle for the purpose.
- > That the owner shall raise monthly bills to the Health Officer, CMC every month.
- > That the CMC requires 19 such vehicles to be hired.
- > That the owner shall Quote price separately for monthly hire charges & fuel price for each km. of running.
- > That the intending bidders shall furnish the quotation in a sealed cover addressed to Health Officer, CMC, Bikash Bhawan, Cuttack by Registered Post.
- > The application should reach at the office on or before dt.25.06.2019.
- > That the opening & finalization of tender process will be on dt.03.07.2019 in the office chamber of Health Officer, CMC, Bikash Bhawan at 4 pm.
- > The applicant bidders should provide 19 vehicles with same make, size & colour within 1 month from the date of finalization of the tender.
- > An amount of Rs.1 lakh shall be deposited as bid security in shape of bank draft payable in favour of Commissioner, CMC, Cuttack which is refundable to the unsuccessful bidders & the successful bidder has to deposit balance amount of EMD to a tune of 2% of the balance value.
