Sub: Regarding elimination of ineligible beneficiaries & exemplary action against visibly rich beneficiaries under NFSA.


Sir,

It has come to the notice of the undersigned that, a good no. of ration cards have been generated in favour of ineligible families as per the exclusion criteria. But it is not understood how this could happen despite existence of several check systems. Although some defects at the time of updation of data in the C.D.C have been noticed yet the biased role of Desk Review Team & Field Verification Team in favouring the influential personalities who are visibly rich cannot be ruled out. This has resulted in generation of ration cards in favour of the ineligible families alike the case of Mayor, CMC, Cuttack.

In the video conferencing dated 28.12.2015 Hon'ble Chief Minister, Odisha has also expressed his serious concern on the issue and directed to take stern action against the influential persons who have entered their name to get the ration card knowing very well that they are not eligible and against the officials as well who during the check system did not exclude them.

In view of the above, it is instructed that the Nodal Officer in respect of Block/ULB shall lodge F.I.R in the local police station against those visibly rich persons who have managed to get the ration card issued in their favour by misuse of their power, position & influence despite a number of restraining instructions issued from the Govt.
