Sub: New Ration Card distribution under NFSA-2013 - resolving field issues thereof.

Madam/Sir,

We are enclosing herewith a copy of the letter No.21122 dated 31.10.2015 of Commissioner-cum-Secretary to Government, Food Supplies & Consumer Welfare Department on the above subject. As per the Government instructions contained in the aforesaid letter;

1. Beneficiaries would submit photo copies of their ration cards (both sides) mentioning required correction of error/changes to be made in name, gender and relationship etc., and corrected card would be provided free of cost within 3 months.
2. Eligible beneficiaries, whose names do not find place in the Final Prepared List (FPL), can submit application along with copy of acknowledgement receipt, and new digitized ration cards will be supplied to eligible beneficiaries within 2 to 3 months following due procedure as per guidelines.
3. Names of ineligible beneficiaries would be removed as per process mentioned in Para-3 of the above letter.
4. Fresh process for publication and objection hearing in respect genuine eligible applicants, who could not apply in the stipulated period, will be started soon.
5. During publication and objection hearing, some families included in the DPL list have been sifted to Suspect List-4 on the ground of one of the nine exclusion criteria. Notice will be issued to such families as mentioned in Para-7 of the aforesaid letter.

Sub: New Ration Cards distribution under NFSA, 2013-resolving field issues thereof.

Madam/Sir,

I am to say that media reports have been received from several districts highlighting different issues which need to be addressed on priority in order to prevent unnecessary clamour in the district.

1. **Mistakes in Ration Card:** There have been reports regarding printing errors in Name, Gender, Relationship, Name of FPS etc found in some Ration Cards during distribution to identified beneficiaries. In order to rectify the mistake, beneficiaries may be asked to submit the Photostat copy of Ration Card (Both side) mentioning required changes to be made along with the documentary proof in concerned Block/ULB offices. The corrected Ration Card will be provided to the beneficiaries free of cost within three months. A register may be maintained to record such applications in the Block/ULB offices.
2. **Non-inclusion of eligible Beneficiaries in Final Priority List (FPL):** Eligible beneficiaries who have not received ration cards as their names did not find place in the FPL can submit application along with Acknowledgement Slip in the concerned Block/ULB. After proper inquiry, new digitized Ration Card will be supplied to the eligible beneficiaries with 2-3 months.
3. **Ration Cards to ineligible beneficiaries:** Some ineligible beneficiaries have managed to get their names included in the FPL and ration cards have been printed in their name. Steps may be taken to gather information regarding such ineligible beneficiaries at their RCs in Blocks/ULBs. After proper field verification a) Steps should be taken to withhold the Ration Card if not distributed at RC level with intimation of such withheld ration cards to the concerned FPS Retailer and b) If ration card has been distributed, steps should be taken to list such ineligible beneficiaries and ask their FPS dealer not to issue FDS items to them. Simultaneously, steps should be taken to delete their names in the master database

through RCMS Centres which are expected to be opened by the end of 1st fortnight of November, 2015.

4. **Non-submission of application:** It is seen that some of the genuine eligible families have not applied or have applied in the two month window between 16th June to 14th August 2015. Those who have not applied are to apply for Ration Card. For later applicants, the entire process of publication and objection hearing will start soon.
5. **Functioning of Ration Card Management System (RCMS) Centre:** The present beneficiary database is a dynamic database which will continuously take care of inclusion of eligible or exclusion of ineligible families from the NFSA database. Such changes would be done at RCMS Centres. That apart, any rectification of mistake or change in any field of Ration Card would also be done at RCMS Centres. In order to take care of the above changes, the RCMS Centres will start functioning in each Block/ULB of the State latest by 16th November 2015.
6. **Missing Ration Cards:** Some districts have reported regarding non-receipt of ration cards (Fully or partially) for some Registration Centres of the district. In order to ascertain the actual number of missing ration cards, the information should be handed over to the concerned Vendor under intimation to the Department in the format enclosed as Annexure-A. The format is a replication of 'Ration Card List' available in Department's website www.foododisha.in which should be downloaded for use. This format has Registration Centre wise details of Ration Card Number for missing ration cards. The abstract for Block/ULB and District needs to be prepared from above RC wise details.
7. **Issuing notices for Suspect list-4:** During publication and objection hearing stage, some of the families in Draft Priority List (DPL) had been shifted to Suspect List-4 on ground of one of the nine exclusion criteria. All these applicants have to be given notice to file their counter. The notice can be downloaded from the system at Block/ULB level for each family or all families of one Registration Centre (RC). The same is to be issued to such families along with date of proposed hearing by BDO/Tehsildar/Executive Officer as Authorised Officer. This downloading and printing is to be taken up once the RCMS Centres start functioning at Blocks/ULBs.

In order to create awareness among beneficiaries about above issues, an advertisement in Odia is being published in the leading Odia dailies by the FS & CW Department. A copy of the same is enclosed at Annexure-B which may be displayed in GPs/Wards/Block, ULB Offices/District Offices/Other Offices and in public places for information of general public.

It should be ensured that genuine beneficiaries should not be left out of NFSA ambit at any cost. Steps should be taken for inclusion of all eligible households in NFSA beneficiary database.

ଜାତୀୟ ଖାଦ୍ୟ ସୁରକ୍ଷା ଆଇନ 2013ର ନିୟମାବଳୀ ଏବଂ ରାଜ୍ୟ ସରକାରଙ୍କ ଅନୁମୋଦିତ ପଦ୍ଧତି ଅନୁସାରେ PDS ହିତାଧିକାରୀ ଚୟନ ପ୍ରକ୍ରିୟା ନିକଟରେ ସମଗ୍ର ରାଜ୍ୟରେ ସମାପ୍ତ ହୋଇଛି । ଚିହ୍ନିତ ଯୋଗ୍ୟ ହିତାଧିକାରୀ/ ପରିବାରମାନଙ୍କୁ ପର୍ଯ୍ୟାୟ କ୍ରମେ ନୂଆ ରେସନ କାର୍ଡ ଯୋଗାଇ ଦିଆଯାଉଛି । ଏହି ପ୍ରକ୍ରିୟାକୁ ତୁଚ୍ଛ ଶୂନ୍ୟ କରିବାକୁ ଯଥା ସମ୍ଭବ ଚେଷ୍ଟା କରାଯାଇଥିବା ସତ୍ତ୍ୱେ ରେସନ କାର୍ଡ ତଥ୍ୟାବଳୀରେ ନିମ୍ନଲିଖିତ ସମସ୍ୟା କିଛି ପରିମାଣରେ ପରିଲକ୍ଷିତ ହୋଇଛି ।

(କ) ଆବଶ୍ୟକ ରେସନ କାର୍ଡରେ ତୁଚ୍ଛ : ଚିହ୍ନିତ ହିତାଧିକାରୀଙ୍କୁ ଦିଆଯାଇଥିବା ରେସନ କାର୍ଡରେ ତୁଚ୍ଛ (ଯଥା - ନାମ, ଲିଙ୍ଗ, ସମ୍ପର୍କ, ସୁଲଭ ଦୋକାନର ନାମ ଇତ୍ୟାଦି) ପରିଲକ୍ଷିତ ହେଉଛି । ଏହାର ସଂଶୋଧନ ପାଇଁ ପାଇଥିବା ରେସନ କାର୍ଡର ଫଟୋକପି ସହ ପରିବର୍ତ୍ତନ ହେବାକୁ ଥିବା ବିବରଣୀ ଉଲ୍ଲେଖ କରି (ଉପଯୁକ୍ତ ପ୍ରମାଣ ସହ) ଆପଣଙ୍କ ବ୍ଲକ/ ପୌରାଞ୍ଚଳ କାର୍ଯ୍ୟାଳୟରେ ତୁରନ୍ତ ଦାଖଲ କରନ୍ତୁ । ସମ୍ପୂର୍ଣ୍ଣ ହିତାଧିକାରୀଙ୍କୁ ସଂଶୋଧିତ ରେସନ କାର୍ଡ ବିନା ମୂଲ୍ୟରେ ତିନି ମାସ ମଧ୍ୟରେ ଯୋଗାଇ ଦିଆଯିବ ।

(ଖ) କେତେକ ଯୋଗ୍ୟ ପରିବାର ତୃତୀୟ ତାଲିକାରେ ଘାଟିତ ହୋଇନାହାନ୍ତି : ଏପରି ପରିବାର, ସେମାନଙ୍କୁ ମିଳିଥିବା 'ପ୍ରାୟ ସ୍ୱୀକାର ପତ୍ର'ର ନକଲ ସହ ବ୍ଲକ କିମ୍ବା ପୌରାଞ୍ଚଳ କାର୍ଯ୍ୟାଳୟରେ ଆବେଦନ କରନ୍ତୁ । ଏହା ଯାଞ୍ଚ କରାଯାଇ 2-3 ମାସ ମଧ୍ୟରେ ରେସନ କାର୍ଡ ଯୋଗାଇ ଦିଆଯିବ ।

(ଗ) କେତେକ ଅଯୋଗ୍ୟ ପରିବାରଙ୍କୁ ନୂଆ ରେସନ କାର୍ଡ ମିଳିଛି : ଏଭଳି ପରିବାରଙ୍କ ବିଷୟରେ ତଥ୍ୟ ଘାନୀୟ ବ୍ଲକ/ ପୌରାଞ୍ଚଳ କାର୍ଯ୍ୟାଳୟରେ ପ୍ରଦାନ କରିବାକୁ ଅନୁରୋଧ । ତଥ୍ୟ ପ୍ରଦାନକାରୀଙ୍କ ପରିଚୟ ଗୋପନ ରଖାଯିବ । ହିତାଧିକାରୀ ତାଲିକାରେ ଘାଟିତ ଏଭଳି ଅଯୋଗ୍ୟ ପରିବାରଙ୍କୁ ଚିହ୍ନିତ କରାଯାଇ ସେମାନଙ୍କୁ ତାଲିକାରୁ ବାଦ ଦିଆଯିବା ସହ ଉପଯୁକ୍ତ ଦଣ୍ଡ ବିଧାନ କରାଯିବ ଏବଂ ସବିଧି ଅର୍ଥ ସାର୍ବିଫ୍ଟକେଟ କେସ୍ ମାଧ୍ୟମରେ ଅସୁଲ କରାଯିବ ।

ଚର୍ଚ୍ଚମାନ ପ୍ରସ୍ତୁତ ହିତାଧିକାରୀ ତାଲିକା ଏକ ଛିର ତାଲିକା ନୁହେଁ । ଏହି ତାଲିକାରୁ ବାଦ ପଡ଼ିଥିବା ଯୋଗ୍ୟ ପରିବାରର ମିଶ୍ରଣ ଓ ଯୋଗ ହୋଇଥିବା ଅଯୋଗ୍ୟ ପରିବାରର ବାଦଦେବା ପ୍ରକ୍ରିୟା ବର୍ଷସାରା ସବୁ ସମୟରେ ଚାଲୁ ରହିବ । ତେଣୁ ତଥ୍ୟାବଳୀରେ କୌଣସି ତୁଚ୍ଛ ପାଇଁ ଜନ ସାଧାରଣ ବ୍ୟସ୍ତ ଓ ବିସ୍ତ୍ରତ ହେବା ଉଚିତ ନୁହେଁ । ଏହି ପରିବର୍ତ୍ତନ ଗୁଡ଼ିକୁ ସାମିଲ କରିବାପାଇଁ ପ୍ରତ୍ୟେକ ବ୍ଲକ/ ପୌରାଞ୍ଚଳ କାର୍ଯ୍ୟାଳୟରେ ରେସନ କାର୍ଡ ପରିଚାଳନା ବ୍ୟବସ୍ଥା (RCMS) ସେକ୍ସର ଖୋଲାଯାଉଛି ।

ଯେଉଁ ଯୋଗ୍ୟ ପରିବାର ରେସନ କାର୍ଡପାଇଁ ଆବେଦନ କରିନାହାନ୍ତି, ସେମାନଙ୍କୁ ବ୍ଲକ/ ପୌରାଞ୍ଚଳ କାର୍ଯ୍ୟାଳୟରେ ଆବେଦନ କରିବାକୁ ଅନୁରୋଧ । କୌଣସି ପରିସ୍ଥିତିରେ ଗୋଟିଏ ହେଲେ ଯୋଗ୍ୟ ପରିବାର ରେସନ କାର୍ଡର ସୁବିଧାରୁ ବଞ୍ଚିତ ହେବେନାହିଁ । ଯୋଗ୍ୟ ପରିବାରଙ୍କୁ ଖାଦ୍ୟ ସୁରକ୍ଷା ଯୋଗାଇବା ପାଇଁ ସରକାର ପ୍ରତିଶ୍ରୁତି ଦେଇ ଏବଂ ଏହା ଜାତୀୟ ଖାଦ୍ୟ ସୁରକ୍ଷା ଆଇନର ପରିସର ଭୁକ୍ତ ।
