thereof, the contractor has to mention **percentage excess or less** over the estimated cost (In figures as well as words) in the prescribed format appended to the tender document. The agreement for the work in conformity with detailed tender call notice are eventually to be drawn in corporation agreement synonyms to P-1 Agreement contract form of public works department of Govt. of Odisha. The bidders may submit tenders / bids for any or all of the works as mentioned in the Annexure as per their eligibility.

(b) As per amendment to appendix-IX, clause 36 of OPWD Code Volume-II, If the rate quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives, the concerned Executive Engineer and other officials of the Cuttack Municipal Corporation will remain present.
